

2025 Academic Year(Second Semester) Kagoshima University Tuition Fee Exemption Application

1. Eligibility

- ① Graduate students (including privately-funded international students)
- ② Undergraduate students (Privately-funded international undergraduate students)

2. Application method and schedule

Obtain the **Application Guidelines for Tuition Fee Exemption [Proprietary System]** and the **List of Forms** from the University website.

I) Applicants for the first semester of the 2025 academic year

If there are **no changes** in your application from the first semester, submit a “**① Application for continuation.**”

If **there are changes** in your application from the first semester, submit a “**② Application for changes.**”

* Changes refers to changes in your family situation (change in the number of dependents) or household finances (change in the income of the head of household, etc.) between the time of your first semester application and October 1, 2025. In addition, if you have renewed the period of validity of any official certificates (residence card, health insurance card, etc.), you need to submit a copy of the renewed certificate.

② Application for changes	 Submit “7. Confirmation of reason for change” on pages 13 to 15 of the Application Guidelines for Tuition Fee Exemption [Proprietary System] and any documents necessary to prove the change.	Wednesday, October 1 to Friday, October 10 * If submitting in person, the deadline is 17:00 10 October. * If sending by post, submissions are valid with a postmark up until 10 October.

II) Second semester application (for those applying for the second semester without applying for the first semester)

Complete ① online registration and ② document submission.

* However, ① online registration will not be conducted for those enrolling in October 2025. After enrolling, complete ② document submission only.

Second semester application	9:00 Wednesday, 10 September to 17:00 to Wednesday, 24 September. (The URL will be posted on the website.)	Wednesday, 1 October to Friday, 10 October * If submitting in person, the deadline is 17:00. * If sending by post, submissions are valid with a postmark up until 10 October.

3. Document submission method

Applications may be submitted by post or in person.

- If submitting by post: The address to send documents is provided in the Application Guidelines. Send by Letter Pack(available from Japan Post).
- If submitting in person: Insert into the white box installed at the Tuition Fee Exemption Counter, Student Life Section, 1st Floor, General Education Building 1, Korimoto Campus



[Important] In principle, documents will not be accepted outside the application period.
